**The Event:** CiderDays is a community event celebrating all things apple in Franklin County, MA. 2010 marks the 16th year of this event and there will be two days of orchard tours, cider making, tastings and workshops plus an indoor/outdoor Marketplace on Saturday at the Shelburne Buckland Community Center, 53 Main Street, Shelburne Falls, MA.

**Hours:** The Marketplace hours are 10:00 AM to 3:00 PM. Each vendor must remain open for the entire duration of the event. The event will be held, rain, snow or shine.

**Set Up/ Breakdown:** All tables must be set up between 8:30–9:30 AM on November 6th. Tables and chairs will be supplied by the organizers. After vendors have unloaded at the Shelburne Buckland Community Center, they must park their vehicle(s) away from the building. Breakdown begins at 3:00 PM.

**Deadline & Acceptance Policy:**

- **Deadline:** Applications and payment must arrive **by the August 15, 2010, deadline.**
- **Acceptance Policy:** Please submit descriptions of all the types of products you will offer for sale. It is the CiderDays Planning Committee's prerogative to give priority to Franklin County vendors first, Massachusetts vendors second, and all other vendors third, while maintaining a diverse range of products. The CiderDays Planning Committee reserves the right to refuse any vendor's application, and will return full space fees with rejected applications. Should you choose to withdraw your application, we reserve the right to withhold 10% of the application fee, and will not refund any fees after October 15, 2010.
